Receipts are issued only once proof of payment has been received.</p> <p>FINAL PAYMENT: Final payment on invoice is due no later than September 4, 2025.</p> <p>EXHIBITION STAND ALLOCATION: Exhibition stands are allocated to facilitate optimum traffic control and exposure of vendor products and services. Preferred exhibition stands can only be guaranteed upon receipt of pre-payment. Grootfontein Show Society reserves the right to reallocate stands should it be deemed necessary to change the allocated stand.</p> <p>CANCELLATION: All cancellations are to be made in writing no later than August 15, 2025 and are subject to a cancellation fee of 50% of the booked stand. 2. **SALE OF;
LASER LIGHTS

It's an agricultural show. Animals can become very agitated when the laser lights are shone into their eyes, and children shoot each other with the BB guns.
You will be asked to leave the premises immediately, if you are unwilling to leave, security will escort you to the gate.
No refund will be made, and no further discussions will be adhered to.
3. Only prepaid stands can be sure of an exhibiting site.
No stall / stand, will be reserved without payment.
4. Vendors must be fully set up by Tuesday, September 16, 2025 at 20:00.
Vendors are to dismantle stands by Saturday, September 20, 2025 at 10:00.
5. Vendors must ensure that the public do not walk through their stand into another exhibitor's stand.
6. It is general business knowledge that a well presented stand will attract the most prospected buyers.
 - All to be neat and clean.
 - Proper lighting.
 - Be visual.
 - Goods displayed in an orderly manner.
 - Interact with the public when they visit your stand.
 - Have enough display surfaces.
 - Have a nice chair for you to sit down in, as hours are long.
 - Have enough business cards available, a big part of your sales might happen after the show.
 - Put personal stuff like handbags, cellphones etc. away and out of the public eye.
 - Outside stands must have a closeable gazebo, tables and chairs.
 - No goods are to be exhibited on the ground.
7. No loud noises, music or television broadcasts that are disturbing or interfering with other exhibitors, will be allowed.



8. You are restricted to exhibiting the goods declared on page 1 of this document.
9. Please bear in mind that management reserves the right to refund you should your exhibition not meet the standards of the Show Society.
10. Judging of stands will take place at 10:00 on 17 September 2025.
 - 10.1 The Judge's decision is final.

No discussion will be entered into, regarding this decision.

The prize giving ceremony will be held @ 17:30 on Wednesday, September 17, 2025, together with the opening ceremony at the Arena.
 - 10.2 Exhibition Halls will be closed for the duration of the Opening Ceremony.

Outside stands; please ensure the safety of your goods during the ceremony.
11. Judging Criteria and Scoring
 - Design and Impact 20 Points
 - Information, Speech and Product Knowledge 20 Points
 - Presentation of Merchandise or Story / Theme 20 Points
 - Originality and Initiative 20 Points
 - Staff Attitude and Appearance 20 Points.
12. All foodstuffs must be placed in packaging when sold and eaten outside.
13. Please have your stand open from 08:00 until 21:00 on September 17 to 19, 2025.

If business is slow, Management will permit an earlier closing time, only if all vendors are unanimous on this.
14. Vendors planning on selling alcohol - this is a contract on its own.

Relevant documents will be sent to you.

Motivation letter and application forms to reach the organizer not later than 01 August 2025.
15. We hire a Security company with whom we are in constant communication during the period of the Show, however, ENTRY AND PARTICIPATION ARE AT OWN RISK.

Nobody can look after yourself and your belongings, better than yourself.

Please be vigilant at all times.

Come to the office if you need more support from Security.
